

Section 1
TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD ROAD RACING COMPANY LIMITED FESTIVAL OF SPEED PRESENTED BY MASTERCARD ON SALE PRIZE DRAW 2026

The terms and conditions set out in this section apply to all of the PRIZE DRAWS and draws operated by the Goodwood Group. Additional Terms and Conditions are included in Section 2.
