

TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD CLUB LIMITED

LIMITED GOODWOOD REVIVAL THE KENNELS VINTAGE MARKET PRIZE DRAW

The terms and conditions set out in this section apply to all of the prize draws and draws operated by the Goodwood Group. Additional Terms and Conditions are included in Section 2.

1. WHO IS PROMOTING/SPONSORING THIS PRIZE DRAW?

CAN I ENTER?
