

Terms and Conditions applicable to Goodwood Motor Circuit, Goodwood Revival Racing Experience Prize Draw

The terms and conditions set out in Section One apply to all of the prize draws operated by the Goodwood Road Racing Company Limited ("Goodwood"), whose registered office is at Goodwood, Chichester, West Sussex PO18 0PX, company number 466176. You can contact Goodwood at this address.

Additional Terms and Conditions for each individual prize draw are included in Section Two. The terms and conditions set out in Section One and Section Two are referred to as the "Rules". In these rules, "we," "our," and "us" refer to Goodwood and "you" and "yourself" refers to an eligible prize draw entrant.

Section One

1. Who is promoting this prize draw?

2. Can I enter?

6. What other conditions am I agreeing to by entering this prize draw?
