

# TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOF GROOMING PARLOUR DRAW

# 1. WHO IS PROMOTING THE DRAW?

#### 2. CAN I ENTER MY DOG INTO THE DRAW?

By entering this draw, you agree:

  from any and all liability or any injury, loss, damage of any kind or disappointment arising
